This notice describes how protected health information about you may be used and disclosed and how you can get access to this information. Please review carefully.

**OUR PLEDGE REGARDING PROTECTED HEALTH INFORMATION:**

Amy Plano, RD understands that protected health information about you and your health is personal. Amy is committed to protecting health information about you. This notice applies to all of the records of your care generated by Amy Plano, RD, whether made by Amy Plano RD's personnel or your personal doctor.

This notice will tell you about the ways in which Amy may use and disclose protected health information about you. I also describe your rights and certain obligations we have regarding the use and disclosure of protected health information. The law requires us to:

- make sure that protected health information that identifies you is kept private;
- notify you about how we protect protected health information about you;
- explain how, when and why we use and disclose protected health information;
- follow the terms of the Notice that is currently in effect.

Amy is required to follow the procedures in this notice. She reserves the right to change the terms of this notice and to make new notice provisions effective for all protected health information that she maintain by:

- posting the revised Notice in our office;
- making copies of the revised Notice available upon request;
- posting the revised Notice on her Web site.

## HOW SHE MAY USE AND DISCLOSE PROTECTED HEALTH INFORMATION ABOUT YOU:

The following categories describe different ways that we use and disclose protected health information without your written authorization.

**For Treatment:** Amy Plano, RD may use protected health information about you to provide you with, coordinate or manage your medical treatment or services. Amy Plano, RD may disclose protected health information about you to doctors, nurses, technicians, medical students, or other personnel who are involved in taking care of you.

Amy Plano, RD may also share protected health information about you in order to coordinate the different things you need, such as prescriptions, lab work and x- rays. She also may disclose protected health information about you to people outside Amy Plano, RD who may be involved in your medical care, such as clergy or others we use to provide services that are part of your care.

She may use and disclose protected health information to contact you as a reminder that you have an appointment for treatment or medical care at Amy Plano, RD. She may use and disclose protected health information to tell you about or recommend possible treatment options or alternatives or health-related benefits or services that may be of interest to you.

**For Payment for Services:** Amy Plano, RD may use and disclose protected health information about you so that the treatment and services you receive by Amy Plano, RD may be billed to and payment may be collected from you, an insurance company or a third party. For example, we may need to give your health plan information about nutrition services you received by Amy Plano, RD so your health plan will pay us or reimburse her for the service. She may also tell your health plan about the nutrition services you are going to receive to obtain prior approval or to determine whether your plan will cover the treatment.

**For Health Care Operations:** Amy Plano, RD may use and disclose protected health information about you for Amy Plano, RD health care operations, such as our quality assessment and improvement activities, case management, coordination of care, business planning, customer services and other activities. These uses and disclosures are necessary to run the facility, reduce healthcare costs, and make sure all her patients receive quality care. For example, she may use protected health information to review our treatment and services to evaluate the performance of the dietitian or Dietetic Intern who is providing your services. She may also combine protected

health information about many Amy Plano, RD patients to decide what additional services she should offer, what services are not needed, and whether certain new treatments are effective. She may also disclose information to doctors, nurses, technicians, medical students, and other Amy Plano, RD personnel for review and learning purposes. She may also combine the protected health information we have with protected health information from other health care facilities to compare how we are doing and see where we can make improvements in the care and services she offers. She may also contact you as part of a fundraising effort.

Subject to applicable state law, in some limited situations the law allows or requires us to use or disclose your health information for purposes beyond treatment, payment and operations. However, some of the disclosures set forth below may never occur at our facilities.

**As Required By Law.** Amy Plano, RD will disclose protected health information about you when required to do so by federal, state or local law.

**Research:** Amy Plano, RD may disclose your PHI to researchers when their research has been approved by an institutional review board or privacy board that has reviewed the research proposal and established protocols to ensure the privacy of your information.

**Health Risks:** Amy Plano, RD may disclose protected health information about you to a government authority if she reasonably believes you are a victim of abuse, neglect or domestic violence. She will only disclose this type of information to the extent required by law, if you agree to the disclosure, or if the disclosure is allowed by law and we believe it is necessary to prevent or lessen a serious and imminent threat to you or another person.

**Judicial and Administrative Proceedings:** If you are involved in a lawsuit or dispute, Amy Plano, RD may disclose your information in response to a court or administrative order. Amy Plano, RD may also disclose health information about you in response to a subpoena, discovery request, or other lawful process by someone else involved in the dispute, but only if efforts have been made, either by Amy Plano, RD or the requesting party, to tell you about the request or to obtain an order protecting the information requested.

**Business Associates:** Amy Plano, RD may disclose information to business associates who perform services on our behalf (such as billing companies;) however, we require them to appropriately safeguard your information.

**Public Health:** As required by law, Amy Plano, RD may disclose your protected health information to public health or legal authorities charged with preventing or controlling disease, injury or disability. To Avert a Serious Threat to Health or Safety, she may use and

disclose protected health information about you when necessary to prevent a serious threat to your health and safety or the health and safety of the public or another person.

**Health Oversight Activities:** Amy Plano, RD may disclose protected health information to a health oversight agency for activities authorized by law. These activities include audits, investigations, and inspections, as necessary for licensure and for the government to monitor the health care system, government programs, and compliance with civil rights laws.

**Law Enforcement:** Amy Plano, RD may release protected health information as required by law, or in response to an order or warrant of a court, a subpoena, or an administrative request. Amy Plano, RD may also disclose protected health information in response to a request related to identification or location of an individual, victims of crime, decedents, or a crime on the premises.

**Organ and Tissue Donation:** If you are an organ donor, we may release protected health information: Amy Plano: 500 Boston Post Road, Orange, CT 06477  
Tel: 203. 671. 3392; Fax: 888.855. 7803 E-mail: amy.plano@yahoo.com to organizations that handle organ procurement or organ, eye or tissue transplantation or to an organ donation bank, as necessary to facilitate organ or tissue donation and transplantation.

**Special Government Functions:** If you are a member of the armed forces, Amy Plano, RD may release protected health information about you if it relates to military and veterans activities. Amy Plano, RD may also release your protected health information for national security and intelligence purposes, protective services for the President, and medical suitability or determinations of the Department of State. Coroners, Medical Examiners, and Funeral Directors: Amy Plano, RD may release protected health information to a coroner or medical examiner. This may be necessary, for example, to identify a deceased person or determine the cause of death. We may also disclose protected health information to funeral directors consistent with applicable law to enable them to carry out their duties.

**Correctional Institutions and Other Law Enforcement Custodial Situations:** If you are an inmate of a correctional institution or under the custody of a law enforcement official, Amy Plano, RD may release protected health information about you to the correctional institution or law enforcement official as necessary for your or another person's health and safety.

**Worker's Compensation:** Amy Plano, RD may disclose information as necessary to comply with laws relating to worker's compensation or other similar programs established by law.

**Food and Drug Administration:** Amy Plano, RD may disclose to the FDA, or persons under the jurisdiction of the FDA, protected health information relative to adverse events with

respect to drugs, foods, supplements, products and product defects, or post marketing surveillance information to enable product recalls, repairs, or replacement.

### **YOU CAN OBJECT TO CERTAIN USES AND DISCLOSURES**

Unless you object or request that only a limited amount or type of information be shared, we may use

or disclose protected health information about you in the following circumstances:

- Amy Plano, RD may share with a family member, relative, friend or other person identified by you protected health information directly relevant to that person's involvement in your care or payment for your care. She may also share information to notify these individuals of your location, general condition or death.
- Amy Plano, RD may share information with a public or private agency (such as the American Red Cross) for disaster relief purposes. Even if you object, we may still share this information if necessary for the emergency circumstances.

If you would like to object to use and disclosure of protected health information in these circumstances, please call or write to our contact person listed on page 1 of this Notice.

### **YOUR RIGHTS REGARDING PROTECTED HEALTH INFORMATION ABOUT YOU**

You have the following rights regarding protected health information we maintain about you:

**Right to Inspect and Copy:** You have the right to inspect and copy protected health information that may be used to make decisions about your care. Usually this includes medical and billing records.

To inspect and copy protected health information that may be used to make decisions about you, you must submit your request in writing to Amy Plano, RD. If you request a copy of the information, we may charge a fee for the costs of copying, mailing or other supplies associated with your request, and we will respond to your request no later than 30 days after receiving it. There are certain situations in which we are not required to comply with your request. In these circumstances, we will respond to you in writing, stating why we will not grant your request and describe any rights you may have to request a review of our denial.

**Right to Amend:** If you feel that protected health information Amy Plano, RD has about you is incorrect or incomplete, you may ask us to amend or supplement the information.

To request an amendment, your request must be made in writing and submitted to Amy Plano, RD. In addition, you must provide a reason that supports your request. Amy Plano, RD will act on your request for an amendment no later than 60 days after receiving the request.

Amy Plano, RD may deny your request for an amendment if it is not in writing or does not include a reason to support the request and will provide a written denial to you. In addition, she may deny your request if you ask us to amend information that:

- Was not created by Amy Plano, RD, unless the person or entity that created the information is no longer available to make the amendment;
  - Is not part of the protected health information kept by Amy Plano, RD;
  - Is not part of the information which you would be permitted to inspect and copy;
- or
- Amy Plano, RD believes is accurate and complete.

**Right to an Accounting of Disclosures:** You have the right to request an accounting of disclosures. This is a list of the disclosures Amy Plano, RD made of protected health information about you. To request this list or accounting of disclosures, you must submit your request in writing to Amy Plano, RD. You may ask for disclosures made up to six years before your request (not including disclosures made before April 14, 2007). The first list you request within a 12-month period will be free. For additional lists, Amy Plano, RD may charge you for the costs of providing the list.

Amy Plano, RD is required to provide a listing of all disclosures except the following:

- For your treatment
- For billing and collection of payment for your treatment
- For healthcare operations
- Made to or request by you or that you authorized occurring as a byproduct of permitted use an
- For national security or intelligence purposes or to correctional institutions or law enforcement regarding inmates
- As part of a limited data set of information that does not contain information identifying you

**Right to Request Restrictions:** You have the right to request a restriction or limitation on the protected health information we use or disclose about you for treatment, payment or health care operations or to persons involved in your care.

We are not required to agree to your request. If we do agree, we will comply with your request unless the information is needed to provide you emergency treatment, the disclosure is to the Secretary of the Department of Health and Human Services, or the disclosure is for one of the purposes described on pages 4-5.

To request restrictions, you must make your request in writing to Amy Plano, RD.

**Right to Request Confidential Communications:** You have the right to request that Amy Plano, RD communicate with you about medical matters in a certain way or at a certain location. For example, you can ask that Amy Plano, RD only contact you at work or by mail. To request confidential communications, you must make your request in writing to Amy Plano, RD. She will accommodate all reasonable requests.

**Right to Paper Copy of this Notice:** You have the right to a paper copy of this Notice at any time by contacting Amy Plano, RD.

#### **OTHER USES AND DISCLOSURES**

Amy Plano, RD will obtain your written authorization before using or disclosing your protected health information for purposes other than those provided for above (or as otherwise permitted or required by law). You may revoke this authorization in writing at any time. Upon receipt of the written revocation, we will stop using or disclosing your information, except to the extent that we have already taken action in reliance on the authorization.

#### **YOU MAY FILE A COMPLAINT ABOUT OUR PRIVACY PRACTICES**

If you believe your privacy rights have been violated, you may file a complaint with Amy Plano, RD or file a written complaint with the Secretary of the Department of Health and Human Services. A complaint to the Secretary should be filed within 180 days of the occurrence or action that is the subject of the complaint. If you file a complaint, Amy Plano, RD will not take any action against you or change our treatment of you in any way.

**COMMUNICATION GUIDELINES:**

1. I agree to reach out to Amy Plano, RD to schedule or re-schedule appointments and only contact my dietitian for nutrition matters.
2. I understand that voicemail is checked once every 24 hours Monday through Saturday. Voicemail and e-mail are NOT checked on Sunday.
3. I will use e-mail for concise communication of administrative issues such as rescheduling an appointment only.
4. I will not use e-mail to discuss the course of treatment and/or diet planning. If I have a question about the course of my care, I need to schedule a session with Amy through her scheduling system, phone or email. Amy has the discretion to address the questions received or wait until the next appointment or schedule an earlier session than agreed upon during correspondence.
5. I agree that I will cancel or re-schedule my appointments no later than 24 business hours in advance. If I am unable to do that I agree to pay for the missed/cancelled or re-scheduled appointment.

**PATIENTS USING INSURANCE:** I understand I am responsible for knowing how my insurance policy works and for presenting any necessary referrals or other documents to my healthcare provider. I am responsible for all copayments, co-insurances and deductibles at the time of service. I am responsible for all costs of services provided if a valid referral from my doctor is needed, but not provided to Amy Plano, RD, my insurance policy is not in effect, or Amy Plano, RD does not participate with my insurance. Payment is expected in full at the time of the visits.

I authorize the release of medical information necessary to process insurance claims to insurance companies or their agencies (including Medicare) for the purposes of filing and payment of medical claims. I authorize payment of medical benefits to the provider. I permit a copy of this release to be used in place of the original.

**CANCELLATION POLICY**

Initial appointments last up to 60 minutes and follow-up appointments are 30 minutes. Amy values your time and hers. Initial appointments missed or cancelled with less than 24 hours notice will be subject to a \$125 cancellation fee. Follow-up visits missed or cancelled with less than 24 hours notice will be subject to a \$80.00 cancellation fee.
